## SECTION II COLLECTIONS AND DISBURSEMENTS

- F. The Commercial Mobile Radio Service Board (Board) shall have the power to levy interest charges at the legal rate of interest established in Section 75-17-1 on any amount due and outstanding from any CMRS provider who fails to remit service charges in accordance with Section 19-5-335(1).

The Board shall levy interest charges at the legal rate of 15% interest based on the date the money is received and not the post-marked date on any amount due and outstanding from any CMRS provider who remits payments thirty (30) days after the end of the calendar month.

## Section VII — MEMBERSHIP

The Commercial Mobile Radio Service Board (Board) reserves the right to recommend to the individual or organization which initiated the appointment, removal of a member who fails to attend three (3) consecutive regularly scheduled meetings of the Board.
